**Abstract.** *The world of education is currently facing a serious problem that occurs to students, namely bullying, which of course has a bad influence on them. This bullying affects the victim to the point of affecting their mental state, causing the perpetrator to act arbitrarily towards the victim. The perpetrator who carries out this action can endanger the physical and emotional health of the victim. The impacts on the victim can be sadness, stress, and mental health disorders, as well as increased anger, and the most deadly of bullying situations is suicide. The purpose of this activity is to educate the school community in general, and students in particular, about various forms of bullying, its dangers, and how to prevent it. Counseling, socialization, and games are used to involve students. Based on initial observations, it was found that 88% of the children, or 44 out of 50 children, had committed verbal bullying. ### Preparation

2. Preperation Method  
Making the discussion topic appropriate for children aged in elementary school. Using simple language and good visuals to make it easy to understand.
3. Planning Schedule  
Establish an appropriate socialization schedule, for instance during PPKn class hours or a mutually agreed-upon special time.

### Implementation of Socialization

1. Opening

Doing the opening by introducing the purpose of socialization and the important of understanding the topic.

2. Telling them that bullying is a bad attitude that cannot be tolerated
3. Playing Educated Movie

Play a short movie that describes any kind of bullying and its impact on the victim. we have to make sure that the short movie is accordance for children

4. Interactive Discussion

Invite students about films that have been watched. and allow the student to share their experience with bullying

5. Explain the definition of bullying, and many types of it (verbal, physical, social, cyberbullying), and ways to avoid and overcome it.

6. Educational Games

Make a fun game that can describe teamwork and empathy between students. examples, the "chain of friendship" game, in this game students must holding hand in hands and try to still connect while facing a "challenge" together.

#### **Closing**

1. Reinforcement of moral messages

Reminding the moral of socialization that bullying is the wrong manner and all of the students have a responsibility to make a safe and pleasant environment

2. Praying and Declaration

At the end of the agenda is praying and declaration together that all students commit to no doing bullying

From this counseling, we hope can help to make a safe school environment, and improve awareness of students for stop bullying.

### **3. RESULT AND DISCUSSION**

This counseling is one of the job descriptions and forms of caring of KKN group 89 Walisongo Islamic University Semarang toward a young generation hopefulness after this counseling there is tolerance between each other so it can prevent bullying behavior. Implementation of this agenda on 29 July 2024 at Kaliwareng Elementary School. The main target is Fourth, Fifth, and Sixth Grade of Elementary School. This counseling is one of the efforts to minimize the bullying behavior around the school.

Bullying is a phrase that is used to describe a human behavior that consists of physical abuse, psychological, social, or verbal that is done repeatedly by someone or a group that has

a dominant position. The National Commission for Child Protection defines bullying as physical and physiological abuse that is done repeatedly to the vulnerable victim. Bullying happens when someone hurting, scared, pressured, make trauma, or makes other people helpless.

There are three types of bullying; (1) physical, which is easier to know than other types. Types of physical bullying are, pinching, spitting, hitting, biting, broking stuff, extortion. (2), verbal bullying can happen in many types, like calling people with a dumb name, mocking, and disseminating wrong information, threatening, saying bad words, and criticizing harshly. (3) Physiological, this type involves systematically lowering a person's self-esteem through exclusion, neglect, and shame; it is the most difficult to see from the outside.

Bullying prevention for children covers a wide range of abuse, including physical, verbal, psychological, and sexual abuse. This article ensures that any act that causes bodily or mental harm to a child constitutes a violation of the child's legally protected rights. As a result, Article 76C establishes a strong framework for the prevention, identification, and handling of bullying.

One of the most important aspects of Article 76C is the obligation to report violence against children to the authorities. This places the responsibility on anyone who understands or sees a need to assist relevant organizations, such as the police or child protection agencies. This way, cases that occur can be handled quickly and efficiently, thereby providing better protection for child victims. In addition, Article 76C establishes a legal framework for prosecuting perpetrators of bullying. Perpetrators of child bullying can face administrative, civil, or criminal consequences under the law. This not only deters perpetrators but also ensures that children who are bullied get justice.

<sup>6</sup> The Child Protection Law (Article 54 in conjunction with Article 9 paragraph 1a) protects children who are bullied. <sup>12</sup> "Children in and around educational units are required to receive protection from actions by educators, parents, and other parties who commit <sup>10</sup> acts of physical, psychological, and sexual violence. Other crimes committed by educators, education personnel, fellow students, and/or third parties." <sup>6</sup> "Third parties". Based on this article, children must be protected. From physical, psychological, or sexual violence, and other violations. Therefore, children who are victims of bullying must receive legal protection.

The counseling agenda especially the explaining topic, was created alternately of Team KKN group 89 Walsongo Islamic University and included a short movie by the title "Stop Bullying" so the students can understand the topic exactly. So after that, there is a question and answer session with a participant. Furthermore, Team KKN Group 89 teaches the students how to take action when seeing bullying behavior. After that Team KKN Group 89 Walisongo
